

Salt Lake Family Justice Center Partners

YWCA: Emergency shelter, transitional housing, danger assessment, safety planning, DV education, referrals, case management, child advocacy, drop-in daycare.

Child and Family Empowerment Services: Short term therapy for adults and children, support groups.

Legal Aid: Protective Orders, Stalking Injunctions, Divorce / Custody cases.

Salt Lake and Unified Police Departments: Filing police reports, detective consultation, and law enforcement victim advocacy.

Salt Lake City Prosecutor and Salt Lake County District Attorney's Offices: Upcoming court cases, general questions on legal proceedings, screen criminal charges, prior case information.

Utah State Department of Workforce Services: Child care, financial, medical, employment, food stamps, training.

Utah State Department of Child and Family Services: Report abuse, neglect, dependency issues involving children.

Holy Cross Ministries: Immigration legal advocacy

Utah Legal Services: Advice on legal issues concerning housing, disability, other non-criminal legal problems. Possible legal representation in Protective Order cases.

Sego Lily Center for the Abused Deaf: Legal and victim advocacy services for hearing impaired clients.

Utah Crime Victims Legal Clinic: Criminal legal advice, possible legal representation in Protective Order cases.

Fourth Street Clinic: Medical services, health education, and medical/health referrals for adults and children.

FJC Sane: 24/7 Free forensic medical exams for rape, strangulation, and DV assault victims in Salt Lake County.

Rape Recovery Center: Individual and group mental health therapy for sexual assault survivors.
